

INTRODUCTION

The Waterford Greenway opened on the 26th March 2017. The greenway is a 46km off road cycling and walking trail along the old railway line between Dungarvan and Waterford City.

The following statistics have been established from a survey commissioned by Waterford City and County Council in 2017 and demonstrate the success of the scheme.

Headline statistics:

- 94% of those surveyed said their overall perception of the Greenway was excellent or good
- 78% rated safety as excellent or good
- 66% rated the conduct of other users as excellent or good
- 68% of people said that the Waterford Greenway was the main motivator for their trip to Waterford.
- 80% of visitors from outside Waterford were in paid accommodation and 45% who stayed overnight, stayed in Dungarvan
- 35% of visitors stayed one night; 32% two nights; 12% three nights and 17% four or more nights
- Of those who were in paid accommodation, 41% stayed in hotels and their average spend on accommodation was €109.50 per night
- 49% of those surveyed were on foot; 51% were cyclists
- It was a first ever visit for 26% surveyed; 15% use it daily 27% use it weekly and 16% use it monthly
- Asked what they liked most about the Greenway, 70% liked the scenery and nature along the route; 51% liked being away from traffic; 36% said it was peaceful and quiet; 21% were interested in its features, i.e. tunnels etc; 18% said the friendliness of the people was its best quality
- 41% of those surveyed said they could think of nothing they disliked

Waterford City and County Council have invested approximately €20m into the project to date. The Waterford Greenway is currently used as a pilot scheme for other authorities in the developmental stages of delivering greenways. We have hosted visits and consultations with Kerry, Cork, Sligo, Kilkenny, Wexford, Westmeath local authorities and consultations with the TII to assist and share our experience.

Following our claim of €1.6m in 2017-2018 we have accrued an additional €850k on agresso due to contractual commitments with landowners and contractors. We have an additional €600k committed to close out the construction phase of the Greenway.

The funding required will contribute to works completed as part of the Waterford Greenway project and in particular will cover the committed funds on the following items:



Re-allocation of Funding 2018 to Waterford and Tipperary County Councils


1. Background

- 1.1 The drawdown of funding under E7 Greenways has been lower than expected. This is partially due to a section of the Galway to Dublin Greenway requiring planning permission following issues necessitating a switch of canal bank. There was also very limited drawdown of funding by Galway County Council and lower than expected drawdown by Kerry County Council.
- 1.2 We now have greater clarity on the likely levels of drawdown for the remainder of 2018 and have detailed funding applications from both and Waterford City & County Councils. Having reviewed their submissions we are recommending making an allocation.

2. Waterford

- 2.1 It should be noted from the outset that WCCC have funded the vast majority of the total (€20m) cost of the expenditure to date on the Greenway. Funding of €2m was initially awarded by the Department to small sections at either end (Dungarvan and Waterford City) of the Greenway under the NCN and Stimulus programmes in 2014. A further allocation of €1.6m was awarded in 2017.
- 2.2 Waterford have recently sent in a submission and have set out that since their claim in 2017, they have accrued an additional €850k due to contractual commitments with landowners and contractors as well as an additional €600k committed to close out the construction phase of the Greenway. These additional costs have been clearly itemised in the application and are in line with previous costs incurred on the construction.
- 2.3 The Department is not obliged to fund these costs incurred by Waterford, however given the low initial allocation to the project allied to the underspend on Greenways in other areas, it is recommended to make this allocation to assist the Council. The Waterford Greenway is also quite rightly held up as an example of best practise in Greenway construction and accommodation works for local landowners. Accordingly, we recommend that an allocation of €1.45m be provided to Waterford County Council in 2018 with the proviso that Waterford are informed that this final allocation by the Department to the project.





4. Recommendation

4.1 It is recommended that the Minister allocate funding of €1,455,000 to Waterford City and County Council for draw-down in 2018.

Funding for Waterford Greenway

Dear Mr. Walsh,

The Department is pleased to inform you that further additional funding is being made available to Waterford City and County Council to complete the outstanding works on the Waterford Greenway. The funding of these works is approved up to a maximum grant amount of €1.455m as set out in the details of outstanding works supplied by you which is attached at Appendix 1. This funding must be drawn down in 2018.

It is essential that projects funded under the *National Cycle Network (NCN)* funding programme are delivered to a very high standard in terms of design and construction. Where proposals involve on road routes the guidance in the National Transport Authority's on-line National Cycle Manual (www.cyclemanual.ie) should be observed and in particular, the principles underpinning this guidance. Reference should also be made to the guidance set out in Transport Infrastructure Ireland's Rural Cycle Scheme Design.

Where deviations and/or relaxations cannot be avoided a case will have to be made to the Department setting out the reasons for same. No contracts or tenders are to be awarded where there are deviations or cost increases without prior Departmental approval. The Department contribution is limited to the amount specified above and no increase will be approved.

Adequately justified claims for eligible expenditure, certified by an officer holding a rank not less than Director of Services, are to be made to the Tourism Development Division, Department of Transport, Tourism and Sport. Claims must be accompanied by photographic or other appropriate evidence, as may be specified by the Department. As claims may be subject to detailed audit and evaluation by the Department or representatives of the Department, Local Authorities must retain all appropriate documentation relating to project delivery.

On completion of the project the National Trails Office may assess the work completed. The cost of this review and any remedial works required as a result of the review will be met from Waterford City and County Council's funds.

Finally, I would bring your attention to the attached terms and conditions that apply to the grant funding being made available. You are requested to sign these indicating your agreement to them and return one copy to the Department.

Specific NCN Terms and conditions:

- 1. Funded local authorities are responsible for future maintenance of any funded route, and must ensure that the route quality, standard and integrity are fully maintained.
- 2. All projects must include provision for automated counters on the route. Annual updates of the number of users on the routes must be made to the Department, and data from counters made available to Department, or a third party, as requested.
- 3. If suitable, and as decided by the Department, routes must be branded as part of a National Cycle Network or any other branding that the Department deems appropriate.

General Terms and Conditions:

The grantee is responsible for management and implementation of the project. A designated project manager will manage the project. This person will be the contact point for all matters relating to the project.

Payment of the Grant:

The grantee is responsible for ensuring that accurate accounts of all expenditure are maintained, including relevant invoices, and that any appropriate documentation, as may be specified by the Department or requested from time to time, is provided to the Department without undue delay.

Grants will be made in the form of reimbursement of eligible expenditure, where this expenditure has been adequately justified by the grantee.

Adequately justified claims, certified by an officer holding a rank not less than Director of Services, must be made to the Department of Transport, Tourism and Sport on completion of the projects. The claims must be accompanied by appropriate documentation, as may be specified by the Department, to support the claims (and must also be accompanied by a report as outlined in the next section).

For the purposes of this condition, "adequately justified" means (in addition to the material referred to under "Reporting Obligations" below) –

- A detailed description of the work to which the claim relates, photographic evidence of completion of the carrying out of the grant aided work and certification that the recoupment claimed is eligible under the terms of the grant and that all conditions of the grant are being complied with,
- Where services are provided by third parties or the project involves purchase of goods, duplicates of relevant receipts to which the claim relates, and
- Certification that no other funding has been or will be claimed or paid by any other State agency in respect of the work to which the claim relates.

Payment of grants is also subject to compliance by the grantee with the reporting obligations set out in the following section.

All accounts and financial/project management systems may be subject to examination and audit by the Department of Transport, Tourism and Sport and/or appointed representatives of the Department and the grantee will afford timely and unimpaired access to any record relevant to the project.

The grantee is required to report in its financial statement, where such a statement is produced, that a grant has been received from the Department of Transport, Tourism and Sport under the Smarter Travel Programme; the amount and term /period of the total grant and the amount accounted for in the financial statements (if less than the entire amount); where relevant, the amount of capital provided and the reporting policies being used in relation to present and future instalments; and whether and how the use of the grant is restricted (i.e. for the particular project).

Reporting obligations

The grantee is obliged to report on progress with the project to the Department of Transport, Tourism and Sport on request.

On completion of the project, the grantee must submit to a final report to the Department. The final report must quantitatively and critically evaluate the project achievements, with reference to the project deliverables and targets. The Department of Transport, Tourism and Sport will be free to circulate the interim and final reports freely, subject to acknowledgement of the grantee as author.

All reports may be published on the Department's websites. Where interim or final reports contain information of a confidential nature, the grantee must also provide a report suitable for publication.

Dissemination and Communication & Publicity

The grantee must ensure that all activities, publicity, and promotional events associated with the project make reference to the funding received from the Department of Transport, Tourism and Sport and publicise the *SmarterTravel* logo. This condition will apply should the Department re-title the Fund and amend the logo.

In the case of delivery of physical/infrastructural projects on the ground, the grantee is required to erect a Smarter Travel plaque or any other signage provided by the Department.

The grantee may, from time to time, be required to participate in meetings hosted by the Department to share knowledge and information on progress with the project.

The grantee is encouraged to publicise the project and raise public awareness of sustainable transport, and the Smarter Travel policy or any subsequent sustainable travel and transport policy, wherever possible. Where possible the Department should be notified in advance of any plans including any presentations, publicity, conferences, media releases etc. Reference to this aspect of work should also be made in reports to the Department.

Evaluation of Projects

The Department of Transport, Tourism and Sport, or its representatives, may wish to carry out independent evaluation of the projects at any stage of the project, or indeed beyond the lifetime of the project and prompt access to material related to the project must be afforded by the grantee.

Liability

The Minister for Transport, Tourism and Sport and his Department shall not be liable for any claims arising from the project. The grantee shall indemnify the Minister and his Department for and in respect of all and any losses, claims, demands, damages, or expenses suffered by the Minister arising from any cause whatsoever. For the avoidance of doubt, the terms of this condition shall survive termination of this agreement for any reason.

Deviations from the original proposal

Any proposals for deviations from the agreed project must be notified in advance, and agreed with the Department. The Department will consider such proposals, including any funding or other implications, on a case-by-case basis and reserves the right to discontinue funding.

Grant termination

Funding is provided by the Department of Transport, Tourism and Sport on a discretionary basis to the grantee and the Department of Transport, Tourism and Sport reserves the right, in the case of non-compliance by the grantee with these terms and conditions, to discontinue funding with one month's notice to the grantee without liability for the full grant.

Withdrawal from project by grantee

Should a grantee withdraw from a project in advance of completion, the Department of Transport, Tourism and Sport reserves the right to seek repayment in part or in full of any grant paid to the grantee.

General Additional Undertaking

The grantee undertakes to adhere to all relevant obligations (e.g. regarding procurement, employment law, usage of grant funding only for the purposes agreed to, Capital Appraisal Guidelines, relevant circulars etc.) which apply to the carrying out of the project.
